

CROSS BORDER CONDITIONS

- A Special International Permit, hereinafter referred to as “the Permit,” must be issued to cross the border. The Permit is subject to evaluation and confirmation by AVIS BUDGET.
- The Permit is granted only for Argentina.
- The Permit must be requested at least 72 business hours before the pickup date, by sending the request to crossborder@avisbudget.cl, attaching the following documents: National ID card (for Chilean citizens and foreign residents) or passport (for foreign visitors), and Valid driver's license. If you wish to include an additional driver, the same documents must be provided for the additional driver.
- **Payment Method:** The rental must be prepaid either through a reservation at www.avis.cl or via a payment link sent by the Contact Center team. The Permit has a cost of CLP \$120,000 + TAX. This amount is additional to the rental fee, insurance, taxes, or any other services and must be paid in advance.
- To guarantee the rental, a credit card must be presented at the time of vehicle pickup in order to process the required deposit. The amount of the deposit will depend on the vehicle category and rental duration.
- CDW coverage is mandatory and must be included in the reservation.
- Coverages and deductibles correspond to those contracted and stated in the rental agreement, applying both in Chile and Argentina.
- In the event of an incident, you must file a police report (in Argentina or Chile, as applicable) in order for insurance coverage to apply.
- In the event of incidents occurring in Argentine territory, no replacement vehicle will be provided.
- The Permit is non-refundable in the event the rental is canceled. If the rental dates are modified, such changes must be made at least 5 days before the initially requested crossing date in order to process the change.
- Vehicles must return to Chile on the date specified in the rental agreement. In case of a possible delay in returning the vehicle to Chile, the customer must immediately notify AVIS BUDGET to determine the appropriate steps to follow. The customer will be responsible for all associated costs that may arise for the vehicle's repatriation, up to the commercial value of the vehicle.
- It is the customer's responsibility to ensure the vehicle's return to Chile, and the customer must accompany the vehicle upon re-entry to the country.
- The rental vehicle may not, under any circumstance, exceed the return date specified in the rental contract to re-enter Chilean territory. Failure to comply with the indicated return date may result in serious fines and costs, which are the sole responsibility of the customer and may exceed USD \$25,000.
- The Permit is valid for a maximum period of 30 days. Any extension must be evaluated and approved.
- AVIS BUDGET is not responsible if the vehicle cannot cross the border to or from Argentina due to weather conditions, road closures, or any other causes beyond the company's control.
- All costs associated with uncovered incidents, border closures, or any other events preventing the vehicle's return to Chile on the scheduled date will be charged to the security deposit.
- Transportation and towing costs due to misuse or cases not covered by the contracted insurance, customs fines, additional rental days, or other related expenses must be borne by the customer.
- In the event the vehicle is abandoned in Argentine territory, the customer will be responsible for all repatriation expenses, with a minimum cost of USD \$10,000.
- Cross-border travel is not permitted for “X class” vehicles (pickup trucks with bars).
- Vehicle returns in Argentina are not allowed.
